Obedience & Agility – top scoring dog in each event – order by August 1, 2013 – \$45.00 each....any pledges received after this date will be honored however the neck ribbons will not be imprinted with your breed. Any medallions sponsored after November 30, 2013 incur a \$10 fee and will be shipped after the event to the recipient. Medallion is neck ribbon imprinted with the breed, event, location and year....Cost is \$45 each.

Deadline for Obedience & Agility medallion pledges is **August 1, 2013**. Deadline for Conformation medallions is **July 1, 2013** for inclusion in the premium list and November 15, 2013 for inclusion in the show catalog.

### **For First Vice President - Harry H. "Butch" Schulman**

I grew up in a different era. I handled my parents' Collies in the 1960s and early 1970s. I sat around the table at Collie Club meetings, picnics, and various events during a time when children were to be seen but not heard. I was a sponge for information. I competed against professional handlers in regular classes who then judged me in junior showmanship competition. I observed breeder judges in the ring like Ada Shirley, Noel Denton, Jane Youngsjohn, George Horn, Bobbie Roos, and Roy Ayers, Sr. as they went over my dogs. It was an educational experience beyond compare. Through this exposure, playing with the dogs in my parents' kennel, sleeping with the puppies in the whelping box, and reading everything in print about our wonderful breed, my love for the Collie evolved. I handled my parents' Smooth bitch, Ch. Merriacre Blue Pinafore to Best of Opposite Sex at the 1972 CCA National Specialty when I was just 12 years old. My mom was my Collie mentor. She also bred multiple Doberman Pinscher and Lhasa Apso champions and taught me about those breeds as well. When I was a kid, I perused through CCA Yearbooks, Collie Cues magazines and dreamed of breeding beautiful Collies one day (Ch. Wickmere Rapunzel is still my vision of perfection), but life took me down another path that I do not regret.

I graduated from the University of Louisville with a Bachelor degree in History and Economics. I studied abroad in Israel. I completed my MBA at George Washington University and a post-Graduate Certificate in Health Care Management at the University of Pennsylvania. I accepted a Commission as an officer in the United States Air Force, spent six years on active duty, and retired in the Reserves as a Lieutenant Colonel after 23 years of service to my country. My wife Robin and I have four children: Benjamin (age 25), Halle (age 20), Matthew (age 17) and Emily (age 15). I have been employed as the Executive Director for the Department of Ophthalmology & Visual Sciences at the University of Louisville School of Medicine as well as CEO of University of Louisville Physicians-Eye Specialists for the past ten years. Strathmoor Sacred Ground (2<sup>nd</sup> AOAC 6-9 at the 2005 CCA National), and her offspring Ch. Overland Frozen In Time (1<sup>st</sup> AOAC 6-9 at the 2007 CCA National) and Ch. Overland Smoke on the Water (AOM at the 2012 CCA National), and my beloved Madame Butterfly (whose oil painting by Mike Cheatham still hangs in my dining room) just to name a few. Because of the wonderful mentors who took the time to help me when I started, I felt that I had to carry on the tradition of giving back to the Collie. Thus I have worked for the club in many different ways over the years. Some of these are:

1. Written several articles for the Yearbook that include a history of the CC of LI for the 1965 Yearbook and THE UNPARDONABLE FAULT which first appeared in the 1975 BULLETIN and was republished in the 1980 Yearbook. I was the writer for the Collie Column for the AKC Gazette.
2. New Hampshire District Director for many years.
3. Speaker for the first Collie Judges Education presentation at the Tampa National chaired by Bobbee Roos and was one of the panel speakers at the Breeders Education Seminar for the 2013 CCA National.
4. Helped produce the first breed study of gait that is now on CD: A STUDY OF COLLIE GAIT that was done for the CC of A by Rachel Page Elliott.
5. Created the CC of A Health Committee when we were first faced with the Corona and Parvovirus out breaks in 1978 and served as Chairman from 1979 until 2000. I was one of the founding members of the CC of A Health Foundation.
6. Served as Chairman for 2 of the TOP 10 Competitions at Nationals in Ohio and Virginia Beach.
7. Re-introduced the CC of A Legislative Committee and have served as co-chairman, a position I still hold today.

Dogs "cleared by parentage" need to submit verification of parents' "cleared status" when placing an ad.* Other available health and/or genetic information, including specific eye ratings, should be referred to as follows: eye examination and/or additional health information is available on request. Breeders and purchasers should be aware that there are differences in grading systems and between individual examiners' findings, and inform themselves about the health subjects.**
