## Second Report of the AKC Delegate

To the Board of Directors:

Michael A. Liosis, AKC/Director of Club Relations, has responded to our questions/inquiries. He wrote “Hal. Re. your 2 requests-- Would it be a good idea NOT to revisit actions already taken since by doing things in the manner they were done required the acquiescence of all or most of those voting?” He answered with a question.

In conversation before the Delegates quarterly meeting, Mike urged that the club step back from creating a “situation” that could reflect unfavorably upon our ability to self-govern. He repeated again that our club constitution is the only legal guide for us. Responding to a question, he said normally, the AKC is not in the business of acting as an arbitrator or mediator except in exceptional instances. AKC has in the past and is even today sanctioning parent clubs for failure to follow their constitutions and bylaws.

Perhaps the best interpretation of the AKC response is to practice self-government by following our constitution and by-laws with guidance from our parliamentarian.

Informally, and as a friend to your Delegate and our club, we are advised to give attention to matters that should be strictly considered in-house. We can agree to disagree, but majority rule prevails. A word of caution: We are approaching needless AKC attention to our club by continuing governing inadequacies and questions. There simply is no other way to interpret the response. One last thought, remember that changes to the constitution require written approval by the full club membership

Action at the September 10, 2013 AKC Delegates meeting in Newark, NJ: Delegates approved a rules change “to eliminate the different times frames for sending premium lists to perspective exhibitors based on the delivery method.” AKC’s financial officer reported that the balance sheet had improved markedly. He said that both improved revenue streams and prudent cost-saving means had yielded positive returns. .

FABULOUS is the new name and purpose of AKC REUNITE--the way home for lost pets. CAR--the companion animal program--has been succeeded by a new program to raise funds for AKC Pet Disaster Relief trailers to emergency management organizations. If CCoFA donates \$1,000 or more, the club’s logo will appear on a trailer. Motions anyone? Please see the AKC press release for more complete info.

### Richard Lingenfelter, Co-Show Chair

In Sylvie's memory I am doing something that I never thought I would have to do and that is being co-chair for the 2015 national speciality to help finish the dream that she started.

I grew up in a air force family traveling to and from Europe all of my school years living in the USA, France, and Germany three time each. After returning from Germany in 1974 we settled in Oklahoma where I attended UCO graduating with a BA degree in art. After working as a commercial artist for nearly 10 years I turned my attention to fine art, Painting , designing Jewelry and Sculptures.

With my sister Sylvie we bred, raised and showed collies under the kennel name of Glenorka Collies finishing 24 Champions rough and smooth. We were blessed to have won smooth Winners Dog twice, smooth Winners Bitch and a Best Opposite to Best of Breed rough at the Collie Club of America National Speciality and not to forget Best of Variety 15 inch at the National Beagle Club, it was then only natural that my art would venture in the direction of dogs and animals.

I have been commissioned to create original Jewelry, Paintings and Bronze sculptures for the past 25 years. I have also had the great honor to have been commissioned to create 10 bronze Memorial Trophies for the Collie Club of America and at present I am working on one for my sister Sylvie who recently passed away for the 2015 CCA National in Oklahoma .... I so wish this was not the case.

Along with Roxann Heit, we hope to make the 2015 CCA National as memorable as the 2011 CCA National that Sylvie had worked so hard for it to succeed.

### Susan Joslin, Trophy Chair

I got my first collie in 1973. While he wasn't a great specimen of the breed he did get me into obedience classes and from there to joining CCA, Sioux Valley Kennel Club and Nebraska Collie Club. I attended the CCA seminar in Chicago and visited several collie breeders before acquiring my first show collie from Beverly Dampf of Alteza Collies in 1975. The first points I put on a collie was at the Collie Club of Colorado in 1976 under judge Trudy Mangles and this dog became my first champion--Ch Alcor the Alteza Kid.

I am currently a member of the Kansas City Collie Club along with CCA and the Quarter Century Group. In the past I have acted as show chairman of Nebraska Collie Club and Kansas City Collie Club. I have held the office of Treasurer and Vice President and Board Member of the Kansas City Collie Club. I have been on the show committee for the National show when held in Kansas City in 1993 and Oklahoma City in 2005. I had the privilege of interviewing for the CCA library Bill and Bettie Crawford of Celestial Collies and to introduce Bettie at the Quarter Century banquet for induction into the Hall of Fame.

I am currently employed by a pension consulting firm where I do accounting for private companies' retirement plans. I continue to breed and show collies carrying the Alcor kennel prefix.

## **New Grand Versatility (GV) Award**

The CCA Versatility & HIC Committee would like to propose a new Grand Versatility (GV) award to complement the current Versatility Award (VA) and Versatility Excellent (VX) award. As the name implies, the requirements for the Grand Versatility Award will be higher than those for the current VA and VX awards. A summary of this proposal is contained in the attached pdf file. We have received very positive input on this proposal from several CCA members who are active participants in the performance venues.

We don't know what process this needs to go through to get CCA approval, but we are hoping that this GV award can be approved for implementation prior to the 2014 CCA National. Since these versatility awards are handled entirely by the

Versatility and HIC Committee, this award would not result in any additional work for the show committee. However, some small additional time may be needed for the award presentations.

## ***Versatility Committee Proposal***

### **THE GRAND VERSATILITY AWARD**

The CCA versatility awards program is designed to recognize collies which have distinguished themselves in both the breed ring and in AKC recognized performance events. These dogs possess the conformation, temperament, intelligence, and herding and working capabilities which represent the essential characteristics of the breed. The CCA Versatility & HIC Committee would like to propose a new Grand Versatility award (GV) to complement the current Versatility Award (VA) and Versatility Excellent (VX) award. The versatility awards are based on a point system which is used to weight each title based on its difficulty. The requirements for the Grand Versatility award will be higher than those for the current VA and VX awards; a double championship will be required in addition to more versatility points. Over the last 10 years, there was an average of about 10 VAs and 6 VXs presented each year. Because of the higher requirements for the GV, less than 5 are expected qualify for the award each year. The CCA versatility awards are presented to any collie, rough or smooth, owned by a CCA member, or member of a CCA member's immediate family, in good standing with the AKC who has fulfilled the requirements for one of these awards. The GV award qualifiers will receive a certificate signed by the club President and a rosette with a streamer listing the dog's name with all AKC titles. The versatility certificate and rosette will be awarded by the CCA President at the next annual CCA National Specialty Show.

### **Meet the Breeds – New York** **Written by Jackie Caruso**

We had another very successful MEET THE BREEDS in NYC this past weekend. I will be posting pictures to FB on the Tri County Collie Breeders Assn website as well as my own FB page and COL has agreed to print an article with some pictures.

As usual, the collie booth was mobbed. I am happy to say there are 1,000 people running around NY with stickers that say "I Love Collies" We gave away almost all of our printed materials. The coloring pages are a big hit with the kids. Our booth doesn't have a lot of frills. We use posters from the pictures from the CFP project and some other performance shots, collies and kids etc. We add to the collection every year. If anyone has a great picture of performance, collies and kids, therapy work, anything that depicts our breed doing what they do best, please send to me. It has to be 300dpi. The AKC must have loved it all because we won a HERDING GROUP 3 in the booth display competition. That was a great surprise. When AKC started this event they wanted booths with a lot of frills in the display. Now I think they are going more toward the ones that are geared to education.

The AKC was very appreciative of the fact that we had good representatives of the breed. All were champions and we had the #1 Rough Collie in the country and his handler who gave up a weekend of showing to demonstrate that show dogs are not just robots we run around the ring with, they can go from a dog show to playing with kids to being great companions. Our #1 Junior came also to help showcase the dogs to the public. We even had a photo taken with the President of the AKC!

I really cannot truly convey the magnitude of this event. It is held at one of the largest event locations in NYC. It is a combination of the AKC and CFA ...there are beautiful displays for the cats. There are performance demonstrations, lots of vendors and of course all the dogs. This is one thing that was troubling this year. Some very popular breeds had no representation. No Aussies, no Border Collies....a lot of empty booths. Perhaps they committed then no one showed up. But the "new breeds", many not suited as family pets are out there in full force. They are promoting their breeds and many times

the people manning in their booths are inexperienced and the dogs may or may not be good examples of their breed. People do not understand that children cannot go running up to just any dog. The collies are so patient and tolerate anything. We never let anyone approach one of the dogs unless we are right there.

People come streaming into MTB all day long. It is nonstop. There is a romantic attachment to this breed like no other. Grown men will come up to us and get tears in their eyes as they tell you about their childhood collie. Many people have had a collie in every generation of their family. We had foreign visitors who had collies. But the thing we heard over and over again this year "you just don't see them anymore"

What do we do to change this? If every collie breeder gave up one day of showing to attend one of these events at the local level it would be a start. Many all-breed clubs are doing these events now. We have the materials available on our files section and in our online storage. I had to turn down two local events because they were the week before the MTB. Many all breed clubs are doing MTB at their shows. Take some time from showing to present our breed. Make an effort to take our collies for a walk in public places so that we keep them in front of the public, it would help.

We cannot accomplish promoting our breed at one or two large events a year. We have to make an effort on the local level.

We have once again committed to the AKC that we will do this again next year. We are already working on some new ideas

There is a lot of preparation, and travel and setup time for this but it is worth it. We all have to give back to our breed.

I, also, want to mention the CCA members who came to NY at their own time and expense.
