The Collie Club of America Working Collie Committee (WCC) is soliciting bids for herding collie enthusiasts to chair and host CCA Herding Regionals. The WCC selects sites based upon number of course and stock combinations available, budgetary considerations, the bidder's experience, completeness and thoroughness of the proposal, distribution of three Regional sites across the country, likelihood of entries, and expanding herding opportunities into new areas. The WCC may ask questions of, request additional information from, or ask for modification to the bid from any or all bidders prior to making its selections.

Please describe any other activities you plan to offer or are considering offering:

All breed AHBA ranch trial in the PM on the 13th that would include a BBQ dinner at Ohadi. The trial would be limited to 15 runs and judged by local judges. The judge will be paid per run with the stock rental at the same rate as the AKC event. Site rental is included in AKC balance sheet. Awards will include HIT and RHIT payout award (Net 25%, 15%) and Q ribbons.

The flow of the event schedule is B course, sheep and ducks will be early in the AM at Ohadi. The remaining AKC trial will be at the Garbarino Ranch. The AHBA trial will be at Ohadi in the PM, essentially allowing stock to rest 6 hours before the AHBA trial. The AHBA trial is a slow pace trial of moving stock in authentic ranch obstacles such as pens, gates, sorting etc. No stock will moved through the entire course, but will be switched with other resting stock in pens during sort activities. Stock will include Dorper and cross ewes and older lambs. Practice sessions will take place at Ohadi Ranch on Friday the 12th of September.

Please describe anything else you'd like the WCC to consider regarding your bid:

Sheep and duck runs 5 head, cattle 3 head. AHBA trial will be a revolving course in which the number of stock vary throughout the course. Sponsor of the AHBA will either be CCA, Idaho Herding Association or Janie Nafsinger.
